Oman has actively pursued a development plan that focuses on diversification, industrialization, and privatization, with the objective of reducing the oil sector's contribution to GDP to 9% by 2020. India's export to Oman grew from USD 630 mn in 2006-7 to USD 1.15 bn in 2010-11. The imports on the other side grew from USD 458 mn to USD 4 bn during the same period on account of imports of petroleum products.
